Eligibility: Grades 3-12. Top U17-U19 players in National Tournaments are disqualified.

Individual Event: Singles and Doubles, age and sex not distinguished.

Class A: U13-U19* or high school students who participate in intramurals

Class B: U13* or beginners 16 to 19 years old

Class C: U11* or beginners 12 to 16 years old

Class D: U11* or beginners up to 12 years old, NO DOUBLES EVENT

*Juniors who have or will participate in USA Badminton sanctioned tournaments are encouraged to play under their suggested class categories, with the top U13 players competing under Class A.

Note: The above classification serves as a guideline. Participants may be moved to a higher or lower Class depending on ability.

Team Event: School Teams shall be composed of 4 singles and 3 doubles entries. School teams with the highest total scores for the seven entries based their individual performance on the following point system wins:
